Call for POSTERS

Its signature event of the year, COSAC's annual Issues in Autism Conference typically attracts nearly 1,400 parents and professionals during two days. The conference planning committee invites you to be a part of this experience by becoming a poster presenter. The deadline for submission is Friday, February 21, 2008. At least one presenter must be available during the poster session on Friday, May 16, 2008 in order to present the poster. All costs associated with conference attendance, including registration and travel expenses, are the responsibility of the presenter(s).

COSAC is pleased to announce that COSAC (provider #848) is approved to offer professional development credit for Poster Session presenters. Each presenter who attends the entire one hour Poster Session may receive two professional development credits through the NJ Department of Education. A corresponding certificate will be provided at the end of the Poster Session.

Posters are a great way to tell others about what worked for your learner or child. Posters can creatively tell the story of someone's progress and be helpful to others. **Parents and teachers also are encouraged to submit poster proposals that showcase an individual's perseverance and success.** Posters should demonstrate a clear relationship between a behavior change and an intervention.

Presentation Format

All posters should be designed to be displayed on an easel, so please mount your poster ahead of time. COSAC will provide the easel. Poster presenters should bring a minimum of 300 handout copies that provide a summary of the poster, including a list of appropriate references for distribution to interested attendees.

Additionally, in case you run out of handouts, we suggest that you bring a sign-up sheet to capture addresses and/or e-mail addresses of attendees who would like a copy of the summary sent to them at a later date.

Adult Services Award

COSAC is pleased to announce that *The Quest Autism Foundation* once again encourages the submission of posters focusing on *adult services* by offering a **\$500 award** for the best poster on adult services. Half of the monetary award (\$250) will directly go toward the organization with whom the poster presenters are affiliated; the other half (\$250) will go toward the poster presenter's registration fee for the **2009** COSAC conference.

Please provide the following information using the same headings, numbering and order as in these instructions:

		act Page—submissions must include actual or anticipated information addressing the following s. Please clearly state whether the information is actual or anticipated.
	A.	Title.
	B.	Abstract of 200 words, typed, double-spaced. The abstract should include:
		Information about the participant/child/student, such as age, abilities and educational placement.
		A description of procedures.
		Baseline and intervention data that demonstrate behavior change as a direct result of the intervention that is narratively explained and graphically displayed.
		A discussion of the contributions and limitations of the intervention, and how the person's life improved.
	C.	Graph of data.

Who will decide what posters are accepted?

A committee of professionals chaired by Linda Meyer, Ed.D., MPA, will review proposals for their relevance to autism spectrum disorders, content, quality and clarity. The lead author will be notified of the review committee's decision by **April**, **2008**.

How will accepted posters be judged?

The poster committee will evaluate each accepted poster based on a point scale on **Friday, May 16, 2008** using the following criteria:

- Poster presents prior research supporting intervention and contains relevant references made to literature.
- Poster presents a clearly defined intervening variable (intervention) and defines a dependent variable (measure).
- The research question is original and useful.
- Measurement procedure is appropriate.
- Appropriate conclusions are drawn and conclusions do not surpass presented data.
- Poster is organized and easy to follow.
- Poster advantageously uses tables, graphs and photographs.
- Poster offers ideas for future research or intervention.
- Overall poster quality.
- Lead presenter's verbal description of the intervention.
